In exercise of the powers conferred u/s 9(5) of the Cr.P.C. 1973, the High Court of Madhya Pradesh here by directs that where the office of the Special Sessions Judge specified by the Government of Madhya Pradesh u/s 14 of the SC/ST (Prevention of Atrocities) Act (Special Judge) is vacant, then any urgent application which may be made or pending before Special Court, shall ***be disposed of by the***, Senior most Addl. Sessions Judge at the headquarters or in his/her absence, by the Senior most Addl. Sessions Judge or Sessions Judge available in the Sessions Division or in *the absence of all of them by the Chief Judicial Magistrate of the District*; and every such Judge or Magistrate shall be deemed to be the Presiding Officer/Judge of the said Court of Sessions (Court of Special Judge) for this purpose.

The High Court Notification no. 1414/Conf./II-II-21/63-Part-II, dt.9.9.96 is hereby withdrawn.


