

**Subject: Cash Management System in Central Government - Modified Control Based Expenditure Management.**

Sir/Madam,


A reference is invited to Government of India, Ministry of Finance, Department of Economic Affairs (Budget Division) OM F.No.12(13)-B(W&M)/2020 dated 08.04.2020 vide which Ministries/Departments have been directed to regulate the Government expenditure and to fix the Quarterly Expenditure Plan in view of the present situation arising out of COVID-19. Grant No.34 - Indian Audit and Accounts Department was kept in Category "B" and allowed to incur 20% expenditure of Budget Estimates 2020-21 during 1<sup>st</sup> quarter (April to June 2020) for the financial year 2020-21.

The Ministry of Finance was requested to relax the expenditure limit during 1<sup>st</sup> quarter under the object head "Salaries". The Ministry of Finance has relaxed the expenditure limit of 20 per cent under the object head "Salaries". However, the expenditure under non-salary heads has been restricted at 10 per cent during 1<sup>st</sup> quarter (April to June 2020). Therefore, the following guidelines may be complied to maintain the expenditure limit during the period from 01.04.2020 to 30.06.2020:

Sl. No.	Head	Guidelines
1.	(a) Salaries (b) OAE/ Departmental Canteen	Only regular salaries including Children Education Allowance to be made. Payment in respect of other allowances such as salary arrears, LTC, Leave Encashment etc. may not be made during the period April to June 2020 without prior approval of Headquarters.
2.	Medical Treatment	Advance payment only in emergency cases may be made.
3.	(a) DTE (b) RRT (c) Publication (d) Other Charges	Expenditure may be stopped.
4.	Office Expenses	Expenditure may be incurred only on committed liabilities which cannot be avoided. However, any arrears for previous period may be deferred till further orders. No expenditure may be incurred under sub-head 'Special Contingencies' during 1 <sup>st</sup> quarter (April to June 2020).
5.	(a) Wages (b) Professional Services	Expenditure may be incurred only for outsourced staff and casual staff during the period.

The expenditure under other non-salary heads (OTA, FTE, Minor Works, GIA and IT) may not be incurred without prior permission Headquarters during the 1<sup>st</sup> quarter of current financial year.
