Union of India and others, dated 27<sup>th</sup> July 2022 and in exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in consultation with the High Court, the Governor of Madhya Pradesh, hereby, makes the following amendments in the Madhya Pradesh Higher Judicial Service (Recruitment and Conditions of Service) Rules, 2017, namely:-

## AMENDMENTS

क्रमांक 1684/मप्रविनिआ/2023-विद्युत अधिनियम, 2003 (क्रमांक 36, वर्ष 2003) की धारा 181 सहपठित धारा 61(ज) तथा धारा 86(1)(ड) के अधीन प्रदत्त तथा इस निमित्त सामर्थ्यकारी समस्त शक्तियों का प्रयोग करते हुए, मध्यप्रदेश विद्युत नियामक आयोग, एतद् द्वारा, मध्यप्रदेश विद्युत नियामक आयोग {ऊर्जा के नवीकरणीय (अक्षय) स्रोतों से विद्युत का सह-उत्पादन तथा उत्पादन}(पुनरीक्षण-द्वितीय) विनियम, 2021 {क्रमांक आरजी-33(II),वर्ष 2021}, जिन्हें एतद् पश्चात् "मूल विनियम"निर्दिष्ट किया गया है, में संशोधन करने हेतु निम्न विनियम बनाता है, अर्थात् :-

मध्यप्रदेश विद्युत नियामक आयोग {ऊर्जा के नवीकरणीय (अक्षय) स्रोतों से विद्युत का सह-उत्पादन तथा उत्पादन} (पुनरीक्षण-द्वितीय) विनियम, 2021 में तृतीय संशोधन

1. संक्षिप्त शीर्षक तथा प्रारंभ :

1.1 ये विनियम "मध्यप्रदेश विद्युत नियामक आयोग {ऊर्जा के नवीकरणीय (अक्षय) स्रोतों से विद्युत का सह-उत्पादन तथा उत्पादन} (पुनरीक्षण-द्वितीय) (तृतीय संशोधन) विनियम, 2021 {एआरजी-33(II)(iii),वर्ष 2023}"कहलायेंगे।

1.2 ये विनियम मध्यप्रदेश के "राजपत्र" में इनकी प्रकाशन तिथि से प्रभावशील होंगे।

1.3 इन विनियमों का विस्तार सम्पूर्ण मध्यप्रदेश में होगा।

2. मूल विनियमों के विनियम 2 में संशोधन

मूल विनियमों के विनियम 2 के उप-खण्ड दस (क) के स्थान पर निम्न उप-खण्ड दस (क) स्थापित किया जाए, अर्थात् :
