

The High Court of Madhya Pradesh at Jabalpur and the Benches at Indore and Gwalior will remain closed for the Summer Vacation from **Monday the 16th May, 2016 to Friday the 10th June, 2016**, both days inclusive.

During the vacation period, urgent Civil or Criminal Matters which are required to be heard by a Division Bench, shall be placed before a Division Bench comprising the senior sitting Judge and other available member, on a particular day.

If only Single Bench is available on a particular day and matter is required to be heard urgently during vacation by Division Bench, then matter may be listed before available Single Bench subject to the provisions mentioned in Chapter 7 Rule 9 (1&2) of M.P. High Court Rules, 2008.

However, all matters pertaining to examination conducted by VYAPAM shall be listed before Division Bench of Shri Justice Rajendra Menon at Principal Seat Jabalpur, Shri Justice P.K. Jaiswal at Bench Indore and Shri Justice U.C. Maheshwari at Bench Gwalior, if available, alongwith senior-most available Judge who is sitting on the day. Otherwise, such matter shall be listed before the available Division Bench during vacation.

Further, if cases listed before the Vacation Court(s) are 'Not Reached', the concerned Vacation Court may issue direction for listing of such Cases on the following day subject to availability and convenience. The said matters be listed before the Vacation Court available on specified day accordingly.

All matters pertaining to examination conducted by VYAPAM shall be listed before Division Bench-I of Shri Justice Rajendra Menon at Principal Seat Jabalpur, if available, alongwith senior-most available Judge who is sitting on the day. Otherwise, such matters shall be listed before the available Division Bench.

If for any unavoidable reason, any Hon'ble Judge is not available to preside over a Bench on the scheduled date(s), the cases to be listed before that Bench will be allotted to other vacation Judge available on that day.

If for any unavoidable reason, any of the Hon'ble Judges is not available on the scheduled date(s) for sitting, the Hon'ble Judge available at the Headquarter will hold the Court on the request made by the Chief Justice on that date.

Mentioning of all (D.B. / S.B.) matters not notified in the Daily List be made before the Hon'ble Division Bench/available senior vacation Judge sitting on that day. However, mentioning of matters already notified in the Daily List shall be made before the concerned Hon'ble Division Bench / Single Bench, where the matter is so listed.

Further, if cases listed before the Vacation Court(s) are 'Not Reached', the concerned Vacation Court may issue direction for listing of such Cases on the following day subject to availability and convenience. The said matter be listed before the Vacation Court available on specified day accordingly.
