- 1- Tenders received from Fax/E-Mail/Telex & incomplete tenders will be rejected.
- 2- Registrar General, High Court of MP, Jabalpur has absolute right to accept or reject any or all tender in part or full without assigning any reason whatsoever or any notice. Entire tender process may be cancelled at any time without assigning any reason or notice.
- 3- Any Conditions/terms given in the tender shall not be binding on the MPSJA.
- 4- Full payment will be made only after satisfactory completion of the delivery of products.
- 5- After issue of work order, any increase in quantity of any item will be paid at the approved rates only. The rates shall remain valid for six months from the date of work order.
- 6- Tender without sample of the products will not be taken into consideration.
- 7- The supplier has to submit the sample of each of the product at his own cost failing which the Financial bid will not be opened. The Academy shall not be responsible for any kind of charges or losses towards presentation of samples along with the tender.

- 8- The sample products shall be given back after the finalization of the product. The unsuccessful suppliers shall collect and take back the sample at their own cost within 7 days of the finalization of tenders failing which the Academy shall not be responsible for reimbursement of any loss.
