7. **The penalty clause of the bid for non-compliance of the maintenance / SLA conditions shall be Rs. 5,000/- per day, per occasion on per fault basis.**
8. **The declaration of OEM is required regarding the successful running of Ubuntu Linux operating system along with all drivers on all the supplied Desktop Computers / All In One (AIO), till the period of warranty.**
9. **There should be well equipped Company Service Centre at High Court Level / State Capital Level.**
