

In exercise of the powers conferred by sub-section 2 of Section 11 of the Code of Criminal Procedure, 1973 (Act No. 2 of 1974) and all other enabling provisions, the High Court of Madhya Pradesh hereby designates Shri Nitiraj Singh Sisodiya, Judicial Magistrate First Class, Indore as Presiding Officer of the Court of Judicial Magistrate First Class for CBI cases, established by the Government of Madhya Pradesh *vide* Notification No. F-1/5/96/21-B(1), dated 3rd March, 2011 for the areas comprising of the districts Indore, Bhopal, Raisen, Sehore, Dewas, Shajapur, Dhar, Khandwa, Rajgarh, Jhabua, Mandsaur, Neemuch, Ratlam, Ujjain, Mandleshwar, Gwalior, Bhind, Datia, Guna, Morena, Shivpuri, Vidisha, Barwani, Burhanpur, Ashok Nagar, Alirajpur, Sheopur and Harda for trial of cases relating to offences investigated by the **Central Bureau of Investigation** in supersession of all its earlier notifications in this regard.

The Headquarter of the Court shall be at Indore.
